3B. Project Description

1. Provide a description that addresses the entire scope of the proposed project.

Homelessness in Kankakee County is influenced by multiple factors indicative of a poor economy that cannot sustain and support the population in the county. The economic challenges that face residents of Kankakee County are exacerbated by unemployment rates and poverty rates that exceed the state averages. The unemployment rate for Kankakee County has ranged from 4.9% to 5.4% over the past 12 months where the state average has been at 4.4%. This data is indicative of Kankakee County being an area that is slow to react to an improving state economy and an area where the unemployment rate exceeds the state average. Likewise, poverty rates exceed the state average where 14.7% of the county’s population is living below the poverty level, as compared to 14.4% statewide. Where the median income is lower than the state average, Kankakee households are earning only 89% of the state average.

Where the state as a whole has seen an increase of 2% of total jobs, Kankakee County specifically lost nearly 1% of jobs. As reported on the 2010 census, Kankakee County is losing jobs at a rate more than fifty times that of the state. Coupled with decreases in affordable housing, many residents of Kankakee County have become homeless and require services provided through this grant initiative.

This project is intended to address the needs of homeless families with children. Full operational capacity is considered to be 15 persons being served at a given point in time. Full capacity will be achieved through referrals from local service agencies and transitional housing for homeless persons.

This project will provide services to the 15 persons and ensure that each is evaluated to ensure full connection to mainstream benefits. Referred adults will be provided with supportive services including case management, life skills instruction, information about and referral to needed services, and transportation to assist them in becoming self-sufficient. Significant work is planned to connect clients to potential job growth within the county. The I-KAN Regional Office of Education will work closely with the Economic Alliance of Kankakee County to be ready to make referrals of clients to identified areas of job expansion within the county. In addition to medical, dental, and mental health needs, other self-care, childcare, time management, organization, budgeting/financial and employment issues will be addressed during the initial assessment and in the individual service plan developed. In order to help the parents shorten their time of homelessness, emphasis will be placed on helping them access other services and on building a support network to sustain their efforts at becoming self-sufficient so that they may ultimately secure affordable permanent housing.

To Whom It May Concern:

I am writing to confirm the availability of the cash match for the Supportive Housing Program proposal being submitted by the Iroquois- Kankakee Regional Office of Education. The I-KAN ROE will obligate at least \$24,419 during the proposal grant period to cover 25% of the cost of the supportive services expenses. This match will be paid from revenue provided from the Kankakee County General Fund.

In addition, the I-KAN ROE the following leverage sources that have funds currently allocated for supportive services for homeless children: \$40,140 from a McKinney Vento grant, \$28,862 from the TAOEP grant through ISBE, and \$9,639 from I-KAN Attendance Assistance Program Local District Cooperative Participation Fees, and \$1,700 from the Kankakee County General Fund.

While these are current amounts, we cannot guarantee that these amounts will remain exact.
