The Salvation Army in Kankakee was a previous recipient of Safe Haven dollars from HUD to offer a safe space for the chronically homeless men of Kankakee. It is currently using ESG dollars to offer rapid re-housing services to those who meet the HUD definition of literally homeless in Kankakee County.

Since 2016, The Salvation Army of Kankakee has expanded services to improve the financial situation of the homeless who are served through shelter voucher or rapid re-housing programs. This was done with the help of a \$25000 grant received to increase the employability of the homeless and to connect them to living wage employment and support services needed to successfully maintain their employment.

The Pathway Home Project (Rapid Rehousing) will seek to rapidly re-house individuals, families, or unaccompanied youth who come directly from the streets, emergency shelters, or are fleeing domestic violence or other persons who meet the criteria of paragraph (4) of the definition of homeless.

SOAR services are immediately offered to anyone who is chronically homeless and without SSI and assistance obtaining SSI is given to those who are disabled and unable to work.
