3B. Project Description

1. Provide a description that addresses the entire scope of the proposed project.

The goals of Your Family Resource Connection(YFRC)Supportive Housing Program is affordable permanent housing for the homeless that forms a base that enables residents to become self-sufficient and independent.

Serving the Chronically Homeless and using the Housing First Philosophy, YFRC provides supportive services to females and their families to assist in establishing a stable living environment and when possible, maintain their current housing.

Approximately 90% of the homeless population served by YFRC have experienced domestic violence or are residents of emergency or transitional shelters within Danville and the surrounding communities and are between the ages of eighteen and sixty. Persons served are offered the opportunity to gain knowledge, education and skills in a variety of areas through one-on-one and group counseling. Staff provide on-site life skills classes where persons served learn skills for budgeting, money management, self -sufficiency, parenting skills, self-esteem, social and personal boundaries, personal hygiene, housekeeping, cooking and laundry. Staff provide a comprehensive array of support services that start with a comprehensive assessment of needs. The comprehensive service array includes care coordination, life skills training, employment assistance, assistance applying for benefits, transportation, and referral to academic and vocational education, child care services, and therapy and drug treatment programs In order to provide services which meet all the identified needs of persons served YFRC collaborates with local community resources such as Salvation Army, East Central Community Action, the Homeless Program staff at the Illiana Veterans Administration Health Care System. Local Mental Health Providers, Catholic Charities, Aunt Martha's, The Prairie Center, New Directions, Vermilion County Drug Court, Vermilion County Mental Health Court and the Homeless Liaison of School District 118 to ensure that children are attending school, are fed and that transportation is provided to and from the school. When a child of a person served in the program experiences difficulties adjusting to their environment, counseling will be provided by staff or appropriate referrals will be made. All of the residents living in our community based permanent supportive housing units were homeless before they came to the Program. Living arrangements for persons served are scattered sites throughout the Danville area and are secured by renewable leases held by the resident. Persons Served have been able to overcome the obstacles of homelessness and fewer domestic violence victims have had to return to their abusive environment. The Your Family Resource Connection program believes that, working together we can create a community where all women and their families have a safe and stable place to live.

Dedicated and DedicatedPLUS

A “100% Dedicated” project is a permanent supportive housing project that commits 100% of its beds to chronically homeless individuals and families, according to NOFA Section III.3.b.

A “DedicatedPLUS” project is a permanent supportive housing project where 100% of the beds are dedicated to serve individuals with disabilities and families in which one adult or child has a disability, including unaccompanied homeless youth, that at a minimum, meet ONE of the following criteria according to NOFA Section III.3.d:

- (1) experiencing chronic homelessness as defined in 24 CFR 578.3;
- (2) residing in a transitional housing project that will be eliminated and meets the definition of chronically homeless in effect at the time in which the individual or family entered the transitional housing project;
- (3) residing in a place not meant for human habitation, emergency shelter, or safe haven; but the individuals or families experiencing chronic homelessness as defined at 24 CFR 578.3 had been admitted and enrolled in a permanent housing project within the last year and were unable to maintain a housing placement;
- (4) residing in transitional housing funded by a joint TH and PH-RRH component project and who were experiencing chronic homelessness as defined at 24 CFR 578.3 prior to entering the project;
- (5) residing and has resided in a place not meant for human habitation, a safe haven, or emergency shelter for at least 12 months in the last three years, but has not done so on four separate occasions; or
- (6) receiving assistance through a Department of Veterans Affairs(VA)-funded homeless assistance program and met one of the above criteria at initial intake to the VA's homeless assistance system.
